## STALLION SERVICE AGREEMENT

I, \_\_\_\_\_, (owner as shown on mare's Certificate of Registration)  
hereby agree to breed \_\_\_\_\_ registration number \_\_\_\_\_  
\_\_\_\_\_ age \_\_\_\_\_ and color \_\_\_\_\_ to the stallion

THREE CHIPS, Reg. No. 713,473, in the year 2012, and pay the breeding fee of \$1250.00 (\$1,000.00 if booked by Feb 1<sup>st</sup>, 2012).

The following are terms of the agreement.

1. A booking fee of \$200.00 payable to DOUBLE L PAINT HORSES is due when this contract is signed and returned. This fee is applied to the total breeding fee but is not refundable. The balance of the breeding fee, plus all mare care or boarding charges will be due and payable when mare is picked up.
2. The mare shall be in a healthy and sound breeding condition. The mare owner hereby gives permission to have the mare treated by a licensed vet and have normal vet services for anything which might insure the mare's well-being, including palpations and ultrasounds. Mare owner accepts responsibility for any vet charges incurred by mare or foal.
3. Breeding season – February 1 thru June 30, 2012.
4. If for any reason the mare is unable to be settled in a reasonable period of time another mare may be substituted with approval from stallion owner.
5. I understand that the stallion owner, DOUBLE L PAINT HORSES, or their employees will not be held responsible for accidents, sickness, or death to the mare or foal.
6. I agree that a live foal is guaranteed for this mating. Should the foal not stand and nurse, the mare owner shall be entitled to return privileges. This will apply only if the stallion owner is notified within three days from the foaling date. This notice must be accompanied by a vet statement. Under the foregoing circumstances and upon receipt of the specified notice, it is agreed:
  - a. Stallion owner shall give to mare owner a return privilege to the stallion the following year only and to the same mare originally booked (unless otherwise mutually agreed in writing between mare owner and stallion owner).
  - b. If mare owner fails to deliver the mare (or a substitute mare if mutually agreed as stated above) for rebreeding the following year, then any and all fees paid shall be forfeited; the

right to rebreed is thereby cancelled and stallion owner is released from any further obligation whatsoever.

- c. If the mare dies or becomes unfit to breed than another mare may be substituted if approved by stallion owner.
  - d. Live color foal guarantee, (LCFG), if the result of the breeding is a breeding stock foal, then a free rebreed will be given.
7. It is further agreed that should the above stallion die or become unfit for service, the mare owner shall be offered a free breeding to another stallion owned by the same farm.
  8. Breeder agrees to diligently try to settle mare; however, if mare fails to settle, for any reason, mare owner will hold stallion owner blameless. Mare owner agrees to give breeder ample opportunity to settle mare.
  9. A Breeders Certificate will be issued to mare owner after all fees and expenses due to stallion owner have been paid, in full, and upon notification of birth of foal.
  10. This contract is non-assignable and non-transferable.
  11. This contact is entered into in the state of Iowa, and will be interpreted and enforced under the laws of that state. If any clause in this contract is against state law, then that clause shall be null and void.
  12. Should either party breach this contract, the breaching party shall pay for the others court cost and attorney's fees related to such breach.
  13. This contract represents the entire agreement between the parties. No other agreements, promises, verbal or implied, are included unless specifically stated in this written contract. Original contract will be kept on file at DOUBLE L PAINT HORSES and copy provided for mare owner.
  14. For shipped semen: a separate contract is required and where applicable is attached to and made a part of this agreement. If using shipped semen, return both contacts.
